Consent for Initial Evaluation for Eligibility under Part B of IDEA (Both must be checked)

- Parents have received Prior Written Notice for an evaluation to determine eligibility under Part B AND
- Parents have provided informed written consent for that evaluation.

Determination of Eligibility for Services beyond Age 3 (One of the Following)

- Child's eligibility was determined using one of the following categories: Speech/language impaired, developmental cognitive disability, physically impaired, hearing impaired, visually impaired; specific learning disability; emotional/behavioral disorder; deaf-blind; other health disability; autism spectrum disorder; traumatic brain injury; severely multiply impaired. **OR**
- Child has a diagnosed condition with a high probability of resulting in Developmental Delay AND the child's educational need for service is clearly documented in the evaluation report. **OR**
- Child has a delay in development of at least -1.5 standard deviations in two or more areas of development and the need for special education services is clearly documented in the current evaluation report. **OR**
- The team has determined that the child is eligible for special instruction and related services according to the override provisions in Minnesota Rule 3525.1354.

Note: This is not a compliance document. Instead, it is to be used as a tool by program staff to ensure that requirements of Part C and Minn. Rule 3525 are met for children transitioning out of Infant and Toddler Intervention to ECSE Services under Part B or other appropriate services.

Consent for Initial Provision of Services under Part B of IDEA

- An IEP was developed prior to the child's 3rd birthday following all appropriate Part B standards Or the child continues to receive services under an IIIP that has been developed following applicable Part B standards. **AND**
- Parents have received Prior Written Notice for the initial provision of services under Part B and have provided informed written consent to implement the proposed IEP or to continue services under the IIIP beyond the child's 3rd birthday.
- Check if parental refusal to provide consent caused delay in evaluation for Part B eligibility or for the initiation of services for Part
- Check if exceptional child or family circumstance caused delay in evaluation or initiation of services resulting in a delay of the initiation of IEP services beyond the child's 3rd birthday. This includes a **delay** in district receipt of written parental consent.
- Check if systems-related reasons resulted in a delay of the initiation of IEP services beyond the child's 3rd birthday.
